### **February 9, 2013 - February 19, 2013:**

*Taipei, Taiwan → Detroit, MI → Lexington, KY → Detroit, MI → Beijing, China → Jinan, China → Taipei, Taiwan*

(to attend business in Lexington, KY, and then to visit Jinan, China, to talk to Shandong SBIR program officers and form a team with a Chinese partner, Prof. Yin, Yi-long)
